Dr. Bandini is a Professor of Pediatrics at the Eunice Kennedy Shriver Center/University of Massachusetts Chan Medical School. She serves as Adjunct Clinical Professor in the Department of Health Sciences at Boston University. Her research focuses on health promotion for youth with intellectual and developmental disabilities (I/DD). Dr. Bandini has conducted studies on dietary intake, physical activity, and weight management in this population. She is the Principal Investigator of the Healthy Weight Research Network for Children with Autism and Developmental Disabilities, funded by the Maternal and Child Health Bureau. She is also the Director of Nutrition for the UMass Chan-Shriver Center LEND program. Here she oversees the development of a nutrition education curriculum for adolescents and young adults with I/DD. She also supervises nutrition students in experiential learning with the I/DD population.

Dr. Bandini earned her Bachelor of Science from the University of Massachusetts, Amherst and her PhD in nutritional biochemistry and metabolism from the Massachusetts Institute of Technology.

For nearly three decades, Dr. DiPietro's research has focused on physical activity. She has worked very hard to combine the two disciplines of epidemiology and physiology to better understand the mechanistic underpinnings of the benefits of exercise.

Dr. DiPietro is recognized internationally as a leader in the field of physical activity and aging. An accomplished and widely published researcher, she has been awarded numerous grants from the National Institutes of Health and the American Cancer Society. She has been invited to lecture around the world. She is a current Fellow of the American College of Sports Medicine and the former Editor-in-Chief of the Journal of Physical Activity and Health.

In 2016, Dr. DiPietro was appointed to the United States Department of Health and Human Services 2018 Physical Activity Guidelines Advisory Committee. She served there as the Chair of the Subcommittee on Aging. In June of 2017, she received the American College of Sports Medicine Citation Award for her career accomplishments. In 2019, she was named to the WHO Physical Activity Guidelines Development Group in which she chaired the Sub-committees on Aging and on Pregnancy.

Dr. DiPietro is a former Epidemic Intelligence Service Officer in the Commissioned Corps of the United States Public Health Service. She joined the Milken Institute School of Public Health in 2008. Previously, at Yale University School of Medicine, she was associate professor of epidemiology and public health and an associate fellow at the John B. Pierce Laboratory.

Dr. DiPietro received her training in epidemiology at Yale University.

# Yolanda Suarez-Balcazar, PhD

Yolanda Suarez-Balcazar is trained as a community psychologist. Her research expands across several interrelated areas of race, culture, disability, and health. Shefocuses on understanding and addressing health disparities among children and youth with intellectual disabilities and their families from underserved backgrounds. She has contributed to the development, implementation, and evaluation of culturally relevant community-based interventions to address health disparities among Latinx families of children with disabilities. She embraces a community-based participatory research and a Social Ecological approach to address concerns facing immigrant families and communities of color with people who have disabilities. She is currently a Co-PI (PI Sandy Magana) on a NIDILRR, DRPP. This project examines the social determinants of health. It aims at designing and testing interventions to prevent obesity among Latinx children with intellectual and developmental disabilities and their families. She is also a Co-Investigator on a grant funded by NIH Office of Minority Health to the city of Rockford, IL. This grant examines the impact of a health literacy and cultural humility initiative on Latinx and African Americans understanding of COVID-19 vaccine risk and benefits.

She is a Fellow of the American Psychological Association and the Society for Community Research and Action. She was recently recognized with the Distinguished Alumna Award from the Department of Applied Behavioral Science, University of Kansas.
